Important Information – Please Read

- **Cancellation Policy:** Reservations must be canceled at least **48 HOURS IN ADVANCE FOR NON-HOLIDAY PERIODS and 72 HOURS IN ADVANCE FOR HOLIDAY PERIODS** in order to avoid a charge of 50% of the total reservation fee. Lack of payment for late cancellations will effect future boarding.
- Drop-offs, pick-ups, and all other visits are by appointment only between the hours of 8-10:30 a.m. or 5-6:00 p.m. Monday through Saturday. Pick-ups only on Sundays between 5-6:00 p.m. **No Sunday drop-offs, please.** (Note: We will always make allowances for true emergencies!) Unscheduled off hours drop-off/pick-up will incur a \$50 fee.
- During holiday periods, Fall and Spring breaks and Summer vacation, you will be responsible to pay for the entire period you have reserved.
- While your pets are boarded at Black Fox Pet Resort (BFPR) they will be handled and treated in a kind and loving manner. They will be properly fed, watered and medicated according to your instructions. Your pet's environment will be cleaned daily and kept properly heated or ventilated as required by weather conditions.
- Dogs who soil themselves will be bathed at owner's expense. Any excessive soiling of suite, will incur an additional \$5 per day cleanup fee.

- Any medical treatment requiring extra care (medicated baths, eye and ear cleaning and/or meds, insulin injections, etc.) will incur additional fee. Oral medication administration will incur an additional minimum fee of \$1.00 per dose, depending on degree of difficulty.
- Your pets will be regularly observed for changes in physical condition. If your pets appear sick or have suffered injury the kennel management has full authority to obtain professional veterinary care at the owner's expense. BFPR cannot take responsibility for those pets that may get sore feet, hoarseness or soiled coats due to their own hyperactivity. Pets that are **in season, visually sick or cannot be handled by kennel personnel** will not be accepted for boarding.
- Pets considered abandoned will be handled according to Bradley County Animal Control Laws.
- When owners request joint boarding for multiple pets, BFPR will not be responsible for injury incurred to pets by each other.
- BFPR does not assume and shall not be held responsible for any liability with respect to the pets listed in this agreement, of any kind whatsoever, arising out of or from the boarding of these pets, or any damages which may accrue from any other cause whatsoever, including loss by fire, theft, disease, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named pets during the term of this contract.
- Bathing is available and can be scheduled at check-in. Pets with fleas, ticks or unusual odors will be bathed at owner's expense.
- BFPR accepts cash, personal checks and travelers checks (no credit or debit cards). Payment in full is expected upon pick-up.
- We reserve the right to refuse admittance or services to any dog exhibiting aggressive behavior.
